Authorized Drivers:

All staff must be authorized by the CDM Oilfield Services Ltd. field supervisor, shop foreman, or President, CEO to operate company vehicles and are required to comply with the safety program policies and procedures.

Driver Qualifications

CDM Oilfield Services Ltd. requires all operators to have the correct and valid class of licence related to the type of vehicle being operated. Drivers must immediately report changes of their status to their field supervisor, shop foreman, or President, CEO.

Authorized Passengers

Passengers in CDM Oilfield Services Ltd. vehicles must have written prior approval from the field supervisor, shop foreman, or President, CEO. In addition, passengers entering oil lease locations must complete site specific orientations, have prior approval from the consultant of that lease, and must be prepared to submit the site specific certificates upon request of the consultant.

Safe Work Practices

- Hose test policy and procedures;
- Pressure washers and steamers;
- Working near moving vehicles or equipment; and,
- Safety analysis (Combo/Vac Truck Hydro Vac).
